

COVID-19 Procedures

December 2020

Augusta Technical College is moving forward to provide workforce education for students through online, hybrid, face-to-face classroom, lab, and clinical environments during the COVID-19 pandemic.

The health, safety, and well-being of students, faculty, staff, and communities will continue to be a priority. The college is following guidelines suggested by the Centers for Disease Control (CDC), the Georgia Department of Public Health, the Governor's Office, as well as the Technical College System of Georgia (TCSG). The following information includes guidance and recommendations utilizing provisions that include social distancing, face coverings, plexiglass shields, increased cleaning/sanitizing, and more.

Faculty/Staff and Students
Faculty, staff and students are expected to comply with these preventive measures outlined by the CDC:
☐ Follow physical distancing guidelines
☐ Wear a face covering while in common areas
☐ Practice proper hand hygiene and respiratory etiquette (cover cough/sneeze)
☐ Stay home if sick or feeling symptoms of illness
Every person is expected to wear appropriate personal protective equipment (PPE) including a face
covering/mask when on campus and unable to maintain social distancing. Face coverings/masks are expected in
areas where physical distancing cannot be maintained. This includes, but is not limited to:
□ Labs
□ Lobbies
□ Restrooms
□ Copier/main rooms
□ Shared offices
□ Hallways

Faculty and students will be responsible for cleaning and sanitizing offices, classroom and lab areas with additional diligence/measures between student groups and student appointments to mitigate the chance of COVID-19 exposure. If we all do our part and address these frequent cleaning needs, there will be far less concern when a positive case is identified on campus. We will know that the high-touch surfaces of the spaces the individual occupied in the days leading up to their illness have already been disinfected. Custodial Services can then follow up with foggers as an additional layer of protection. If your department needs cleaning supplies, these products can be requested from Facilities and are listed on the Supply Request Form.

What to Do: Employees

If a student notifies you that he/she are ill. Notify your supervisor. If you are ill. Employees who are experiencing symptoms of COVID-19, have tested positive, or have been
directly exposed:
☐ Do not go to work, or if symptoms begin while at work, leave work immediately. See <u>COVID-19 Case</u>

guidance recommends a time-based return strategy that is determined based on a person's health status.)
☐ Mrs. Sheila Hill, Vice President of Administrative Services, logs student and employee information in the
Technical College System of Georgia (TCSG) portal. Mrs. Shannon Bentley Patterson sends the employee and
potentially infected employees a COVID notification by email. This includes custodians and security who may
have come in contact with the infected person.
Symptomatic persons with confirmed COVID-19 or suspected COVID-19 can return to work or school
after:
☐ At least 3 days (72 hours) have passed since recovery, which is defined as "resolution of fever without the
use of fever-reducing medications AND improvement in respiratory symptoms (e.g., cough, shortness of
breath)"; AND,
☐ At least 10 days have passed since symptoms first appeared.
Asymptomatic persons with confirmed COVID-19 can return to work or school after:

☐ At least 10 days have passed since the positive laboratory test and the person is asymptomatic.

When to start and end quarantine

Stay home for 14 days after last contact with a person who has COVID-19. Even if you test negative for COVID-19 or feel healthy, you should stay home (quarantine) since symptoms may appear 2 to 14 days after exposure to the virus. For additional guidance, please refer to the Centers for Disease Control and Prevention website.

What to Do: Students

\square Do not go to class, or if symptoms begin while in class, leave class immediately.

□ At least 3 days (72 hours) have passed since recovery, which is defined as "resolution of fever without the
use of fever-reducing medications AND improvement in respiratory symptoms (e.g., cough, shortness of
breath)"; AND,
☐ At least 10 days have passed since symptoms first appeared.
Asymptomatic persons with confirmed COVID-19 can return to school after:
\Box At least 10 days have passed since the positive laboratory test and the person is asymptomatic.
□ Note: Asymptomatic persons who test positive and later develop symptoms should follow the guidance for
symptomatic persons above.
Asymptomatic persons who have a known exposure to a person with COVID-19 without appropriate
PPE can return to school after:

☐ They have completed all requirements in the Department of Public Health guidance for persons exposed to
COVID-19.
\square Note: If this person is tested for COVID-19 during the 14-day quarantine period, a negative test result would
not change or decrease the time a person is monitored, but a positive test would move the person into one of the
above categories.

When to start and end quarantine

Even if you test negative for COVID-19 or feel healthy, you should stay home (quarantine) since symptoms may appear 2 to 14 days after exposure to the virus.
