



Free Application for Federal Student Aid (FAFSA)

If you do not have a bachelors degree, and you would like to find out if you qualify for the Pell Grant

log on to:

www.fafsa.gov

Create a FAFSA account, and complete and submit a FAFSA application. You will receive an initial assessment as to whether you are eligible and how much you may be eligible for. After the Department of Education processes your FAFSA, you will receive a final decision in about 3 business days identifying how much you may be eligible for based on household size and total household earned income for the previous two tax years.

Apply for Your VA GI Bill

Certificate of Eligibility

1. Log on to va.gov
2. Click on “Apply for Education Benefits.”
3. Click on “Find Your Education Benefit Form.”
4. Click on “Apply for New Benefit.”
5. Respond “Yes” to Veteran or Service Member Claiming Benefit Based on Your Own Service.
6. Respond “No” to National Call to Service.
7. Click on “Apply Now.”
8. Click on “Start the Education Application.”

Complete and submit the VA Form 22 -1990 application.

NOTE: Your will need to know your service dates and banking information. If you are using the Post-9/11 and you are still on active duty, you will not receive a **Housing Stipend.**

Serving those who have served

Chapter 30 Montgomery GI Bill

Individuals who served on active duty for a period of 24 months or more, contributed \$100 per month for 12 months, and received an honorable discharge are eligible for education benefits under the Montgomery GI Bill.

Chapter 31 Voc/Rehab

Transitioning service members and veterans who received a service-connected disability rating of 20-percent or greater can apply for Chapter 31 Vocational Rehabilitation & Employment Program. Disability award letter must be less than 12 years old. If approved for the program, veteran can receive up to 48 months of benefits.

NOTE: Apply for Chapter 31 on ebenefits.

Chapter 33 Post-9/11 GI Bill

Individuals who served on active duty after September 10, 2001 for a period 3 to 36 months or more and received an honorable discharge may be eligible for the Post-9/11 GI Bill.

Chapter 35 Dependent Education Assistance Program

Spouses and dependent children of veterans who receives a 100-percent total and permanent disability rating may be eligible for up to 36 months of Chapter 35 Dependent Education Assistance.

Chapter 1606 Montgomery GI Bill National Guard & Reserves

National Guard and Reserve members of all services may be eligible for Chapter 1606 if it is part of their enlistment contract. They can only use the benefit while currently serving. Once they separate from the Guard or Reserves, the benefit expires.
